Purpose:

The Canadian Valley Technology Center Board of Education recognizes the importance of providing access to quality career and technical education. The Next Step Tuition Waiver has been established to provide educational opportunities for eligible citizens 23 years old and younger who reside in the district. The Next Step Tuition Waiver will cover tuition for one Canadian Valley Technology Center full-time programs and eligible short-term courses that prepare students for a new career; develop new and emerging job skills; ease workforce transition; and/or enhance career development. The Next Step Tuition Waiver is available for up to one full-time programs and of eligible short-term courses.

Student Eligibility:

- Applicant must be twenty-three years of age or younger on the first day of class.
- Applicant must live in the Canadian Valley Technology Center school district.
- Applicant must complete a FAFSA application
- Adult students must have a high school diploma or equivalent to be eligible for full-time programs.
- High school students or students working on their high school equivalency are eligible for short-term courses provided they are in good standing and on track to earn a diploma.

Performance and Behavior

Students must:

- Make satisfactory progress toward completion of the program
- Maintain a B average or better
- Stay in compliance with the CV Tech attendance policy
- Have no disciplinary problems

Students may be placed on probation for violating the terms of the Next Step Tuition Waiver.

Continued violations will cause a loss of waiver benefits and require payment of applicable tuition.

Application Steps for Next Step Tuition Waiver

The Next Step Tuition Waiver will cover the tuition for one full-time program and eligible short-term program provided the student does not qualify for any other scholarships or waivers. Students are required to fill out the FAFSA in order to be eligible to be considered for the Next Step Tuition Waiver. The Next Step Tuition Waiver will be in effect after all other outside sources have been exhausted.

Students will need to turn in this document with the required documentation for this waiver. The following is a checklist to help you make sure all of the steps and documentation are complete. Please verify with a CV Tech Counselor or ACCD Employee that you meet the following criteria.

Application and Documentation Checklist

- Complete CV Tech's assessment process/test waiver (Full-time Programs)
- Complete a FAFSA application
- Visit with a CV Tech Career Counselor (Full-time Programs)
- Complete the Next Step Scholarship Application
- Proof of High School Diploma or Equivalent
- Proof of age such as Driver's License, Birth Certificate, etc.
- 2 Proofs of Residency (gas, water, electric, mortgage statement, lease agreement)
